State and National Policy Initiatives Having built an expansive statewide activist network, One Hundred Miles helped lead a multi-faceted campaign to advocate for the passage of legislation to protect Georgia's marshes, rivers, and groundwater in 2016. One Hundred Miles helped coordinate efforts to pass legislation that would protect Georgia's waters from contamination from coal ash. As a member of the leadership team of the Georgia Water Coalition, we coordinated over 250 organizations and thousands of citizens to lobby members of the 2016 General Assembly to pass the legislation. This work will continue in 2017. At the national level, One Hundred Miles led a campaign to build local and state opposition to the US Bureau of Ocean Energy Management (BOEM) plan to lease offshore land for drilling for oil and gas reserves. We worked with national partners to carry coastal Georgia's citizen's concern to Washington DC where we communicated with our federal elected officials.

Local Conservation Initiatives In 2016, One Hundred Miles worked to build depth within the Georgia Coast Collaborative, a partnership of 13 advocacy organizations and land trusts working on coastal conservation in Georgia. Members of the collaborative released a report announcing our vision and goals for the conservation of our coast. Additionally, at the local level, we continued our work to protect the Cumberland Island National Seashore from threats such as the spaceport and high-density development.

Form 990, Part III, Line 4c:

Outreach and Education Initiatives One Hundred Miles' Coastal Education Project is an ambitious effort to educate and engage Georgia's citizens and visitors about the ecological and cultural significance of our 100 miles. Through a variety of community programs, digital communications, wide-reaching media outreach, and citizen action opportunities, we educated more than 10,000 people in 2016, ensuring they had the knowledge and tools to advocate responsible decisions on behalf of our coast's wildlife and wild places. In 2016, One Hundred Miles continued our "Nature and the Arts" workshop series to connect artists and outdoor enthusiasts with the natural world through writing, painting, and photography. We exhibited at festivals and conferences across the state, once again hosted our annual Capitol Conservation Day bus trip to Atlanta, and prepared to launch our first annual Choosing to Lead Conference, which was held on January 7, 2017. Though the conference was held in 2017, the preparation, marketing, collaboration, and other actions necessary to make it a success occurred in 2016.
