

HELP STOP CAMDEN COMMISSIONERS FROM PURCHASING PROPERTY FOR SPACEPORT CAMDEN!

Thanks to our Camden County Commissioners, we, as taxpayers, are on the hook to pay nearly \$7 Million to purchase a 4,000-acre property that is heavily contaminated with toxic waste as the future home of Spaceport Camden.

Spaceport Camden is a bad idea; and purchasing and building it on this property makes it even worse!

Here's why:

- Camden County will own the 4000-acre property outright, and the property is heavily contaminated with toxic waste.
- County ownership means that all of us will be responsible for the cost of expensive environmental monitoring and potential remediation of hazardous waste.
- The Option Contract between the County and Union Carbide requires the County to purchase a \$10,000,000 environmental liability policy to protect Union Carbide.
- Spaceport Camden is not economically viable because no one is going to pay the heavy insurance costs to launch rockets over Cumberland Island National Seashore, people and private residences. They can simply launch at one of the many spaceports that are directly on the coast.
- By purchasing the property, Camden County will remove the property from the tax digest, resulting in taxpayers picking up a greater share of the cost to operate our government.
- Our Commissioners have just raised property taxes 19% ... we can expect even greater increases in upcoming years if they move forward with the purchase and the spaceport project.

PETITION TO REPEAL RESOLUTIONS OF CAMDEN COUNTY
BOARD OF COMMISSIONERS

WHEREAS, the Camden County Board of Commissioners have adopted resolutions authorizing Camden County to enter into and extend the term of that certain Option Contract by and between Camden County and Union Carbide Corporation (the "Union Carbide Option Contract"), whereby Union Carbide Corporation has granted Camden County the right to purchase 4,011.54 acres in Camden County, Georgia (the "Union Carbide Property");

WHEREAS, the registered electors signing this petition desire to compel the Probate Court of Camden County to call a special election for the purpose of submitting the repeal of the resolutions authorizing the Union Carbide Option Contract and its renewal or extension to the registered electors of Camden County for approval or rejection in accordance with Article IX, Section II, Paragraph 1(b)(2) of the Constitution of the State of Georgia;

NOW, THEREFORE, the undersigned elector hereby petitions the Probate Court of Camden County to submit the following question concerning the repeal of the resolutions authorizing the Union Carbide Option Contract to a special election of the registered electors of Camden County, Georgia for approval or rejection:

"Shall the resolutions of the Board of Commissioners of Camden County, Georgia authorizing the Option Contract with Union Carbide Corporation and Camden County's right and option to purchase the property described therein be repealed."
